A Ratepayer of the R.M. of Saskatchewan Landing No. 167 in the Province of Saskatchewan.

**WHEREAS:** Valley Water has full control over the Valley Water Well located at SE 14-19-14;

**WHEREAS:** Ratepayers are desirous of hauling water from the Valley Water Well;

**NOW THEREFORE** in consideration of these premised and mutual terms that the Valley Water and Ratepayer agree to the following:

1. Absolutely no spray equipment on the well site -- pails, hoses, chem.-handlers, spray tanks, etc.
2. Valley Water will be using a key-fob system for the Valley Water Well and will be charging \$50.00 for the key-fob which will be available at the RM of Saskatchewan Landing No. 167 office in Stewart Valley.
3. The key-fob that you receive from the R.M. of Saskatchewan Landing No. 167 can't be given to anyone else -- you, alone, are responsible for it.
4. Being that you are a Ratepayer of the R.M. of Saskatchewan Landing No. 167 you will be charged \$.01 per imperial gallon for any water you extract from this water source.
5. The R.M. of Saskatchewan Landing No. 167 will be billing you on a quarterly basis by calculating the amount of time the key-fob was activated by the known number of imperial gallons/minute each pump pumps at calibrated accordingly.
6. If the bill remains unpaid after 30 days a notice giving 15 days to pay account will be sent, if bill remains unpaid after the 15 days stated in the notice the key-fob will be deactivated until the bill is paid. If you still don't pay the bill by December 31 we will add it to your tax roll properties.
7. If you have outstanding accounts receivable invoice with this RM the use of that key-fob will be rescinded -- we will deactivate the key-fob and you will not receive you \$50 deposit back.
8. Any abuse or non-compliance shall result in the key-fob being deactivated and you will have to go elsewhere for water -- no exceptions.

I, \_\_\_\_\_ ratepayer of the R.M. of Saskatchewan Landing No. 167 swear that I have read the above regulations and I agree to abide by them. I also acknowledge that I have received key-fob # \_\_\_\_\_, and will not allow said key-fob to be used by anyone else. I also acknowledge that if I have not followed the rules and regulations of Valley Water, I will forfeit my right to the key-fob and access to the Valley Water Well.
